MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON NOVEMBER 22, 2017.

ORDINANCE NO. 2017-11142

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF SEVEN THOUSAND PESOS  
(P7,000.00) FROM THE APPROPRIATION FOR REPAIR & MAINTENANCE – OFFICE EQUIPMENT; AND REPAIR  
& MAINTENANCE - IT EQUIPMENT; UNDER THE OFFICE OF THE MUNICIPAL MAYOR TO OFFICE SUPPLIES OF  
THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION  
ASSEMBLED:

**Section 1.** There is an appropriation for Repair & Maintenance - Office Equipment amounting P2,000.00; and  
Repair & Maintenance IT Equipment amounting P5,000.00; under the Office of the Municipal  
Mayor, San Pablo, Zamboanga del Sur;

**Section 2.** The total amount of Seven Thousand Pesos (P7,000.00) shall be augmented to the appropriation  
for Office Supplies of the same office.

**Section 3.** Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian  
concerned, may by ordinance, be authorized to augment any item in the approved annual  
budget for their respective offices from savings in other items within the same expense class of  
their respective appropriations, (Art. 454 of RA 7160).

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
