(Under the Local Government Code of 1991) HELD AT THE OFFICE OF THE MUNICIPAL VICE  
MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON NOVEMBER 22, 2017.

ORDINANCE NO. 2017-12141

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF NINETEEN THOUSAND EIGHT  
HUNDRED FIFTY PESOS (P19,850.00) FROM THE APPROPRIATION FOR MEMBERSHIP DUES, REPAIR &  
MAINTENANCE - IT EQUIPMENT; PRINTING & BINDING EXPENSES; OTHER MAINTENANCE & OPERATING  
EXPENSES; OTHER SUPPLIES EXPENSES; AND REPAIR & MAINTENANCE – OFFICE EQUIPMENT UNDER THE  
OFFICE OF THE MUNICIPAL BUDGET OFFICER TO TRAVELLING EXPENSES AND TELEPHONE EXPENSES OF THE  
SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION  
ASSEMBLED:

**Section 1.** There is an appropriation for Membership Dues, amounting P1,700.00; Repair & Maintenance IT  
Equipment amounting P2,000.00; Printing & Binding expenses amounting P1,000.00; Other  
Maintenance & Operating Expenses amounting P2,000.00; Other supplies amounting P9,400.00;  
and Repair & Maintenance - Office Equipment amounting P3,750.00; under the Office of the  
Municipal Budget Officer, San Pablo, Zamboanga del Sur;

**Section 2.** The total amount of Sixteen Thousand One Hundred Pesos (P16,100.00) shall be augmented to the  
appropriation for Travelling Expenses, while the total amount of Three Thousand Seven Hundred  
Fifty Pesos (P3,750.00) shall be augmented to the appropriation for Telephone Expenses of the  
same office.

**Section 3.** Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian  
concerned, may by ordinance, be authorized to augment any item in the approved annual  
budget for their respective offices from savings in other items within the same expense class of  
their respective appropriations, (Art. 454 of RA 7160).

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
