ORDINANCE NO. 2017-12144

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TEN THOUSAND PESOS  
(P10,000.00) FROM THE APPROPRIATION FOR REPAIR & MAINTENANCE – OFFICE EQUIPMENT UNDER THE  
OFFICE OF THE MUNICIPAL LOCAL GOVERNMENT OPERATION OFFICER (MLGOO) TO OFFICE SUPPLIES  
EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION  
ASSEMBLED:

Section 1. There is an appropriation for Repair & Maintenance - Office Equipment amounting P10,000.00  
under the Office of the Municipal Local Government Operation Officer, San Pablo, Zamboanga  
del Sur;

Section 2. The total amount of Ten Thousand Pesos (P10,000.00) shall be augmented to the appropriation for  
Office Supplies of the same office.

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian  
concerned, may by ordinance, be authorized to augment any item in the approved annual  
budget for their respective offices from savings in other items within the same expense class of  
their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

Session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
