## ORDINANCE NO. 2017-12145

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF SEVEN HUNDRED EIGHTY
THOUSAND PESOS (P780,000.00) FROM THE APPROPRIATION FOR REPAIR & MAINTENANCE – HEAVY
EQUIPMENT UNDER THE OFFICE OF THE MUNICIPAL MAYOR TO THE APPROPRIATION FOR DIESEL, FUEL OIL
AND LUBRICANTS OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

- Section 1. There is an appropriation for Repair & Maintenance Heavy Equipment amounting Seven Hundred Eighty Thousand Pesos (P780,000.00) under the Office of the Municipal Mayor, San Pablo, Zamboanga del Sur;
- Section 2. The total amount of Seven Hundred Eighty Thousand Pesos (P780,000.00) shall be augmented to the appropriation for Diesel, Fuel Oil and Lubricants of the same office.
- Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).
- Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
