**APPROPRIATION ORDINANCE NO. 34-2024**

**"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) FROM THE APPROPRIATION FOR PRINTING & BINDING; OTHER MAINTENANCE & OPERATING EXPENSES; REPAIR & MAINTENANCE – OFFICE EQUIPMENT AND REPAIR & MAINTENANCE – IT EQUIPMENT UNDER THE OFFICE OF THE SANGGUNIANG SECRETARY TO TRAVELLING EXPENSES OF THE SAME OFFICE."**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:**

**Section 1.** There is an appropriation for **APPROPRIATION FOR PRINTING & BINDING; OTHER MAINTENANCE & OPERATING EXPENSES; REPAIR & MAINTENANCE – OFFICE EQUIPMENT AND REPAIR & MAINTENANCE – IT EQUIPMENT UNDER THE OFFICE OF THE SANGGUNIANG SECRETARY** under the office of the Sangguniang Secretary, San Pablo, Zamboanga del Sur;

**Section 2.** The total amount of **FORTY THOUSAND PESOS (P40,000.00)** shall be transferred to wit:
