**APPROPRIATION ORDINANCE NO. 36-2024**

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FORTY TWO THOUSAND SIX HUNDRED SIXTY PESOS (P42,660.00) FROM THE APPROPRIATION FOR ACCOUNTABLE FORMS EXPENSES; OFFICE SUPPLIES EXPENSES; TELEPHONE EXPENSES-MOBILE; OTHER SUPPLIES EXPENSES; AND PRINTING & BINDING EXPENSES UNDER THE OFFICE OF THE MUNICIPAL TREASURER TO TRAVELLING EXPENSES AND REPAIR & MAINTENANCE-OFFICE EQUIPMENT OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

**Section 1.** There is an appropriation for **APPROPRIATION FOR ACCOUNTABLE FORMS EXPENSES; OFFICE SUPPLIES EXPENSES; TELEPHONE EXPENSES-MOBILE; OTHER SUPPLIES EXPENSES; AND PRINTING & BINDING EXPENSES UNDER THE OFFICE OF THE MUNICIPAL TREASURER TO TRAVELLING EXPENSES AND REPAIR & MAINTENANCE-OFFICE EQUIPMENT** under the office of the Municipal Treasurer, San Pablo, Zamboanga del Sur;

**Section 2.** The total amount of **FORTY TWO THOUSAND SIX HUNDRED SIXTY PESOS (P42,660.00)** shall be transferred to wit:
