APPROPRIATION ORDINANCE NO. 37-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWENTY-FIVE THOUSAND PESOS (P25,000.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES; OTHER SUPPLIES; TELEPHONE EXPENSES - MOBILE; PRINTING & BINDING EXPENSES; REPAIR & MAINTENANCE - IT EQUIPMENT AND OTHER MOOE UNDER THE OFFICE OF THE MUNICIPAL BUDGET OFFICER TO TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **APPROPRIATION FOR OFFICE SUPPLIES; OTHER SUPPLIES; TELEPHONE EXPENSES - MOBILE; PRINTING & BINDING EXPENSES; REPAIR & MAINTENANCE - IT EQUIPMENT AND OTHER MOOE** under the office of the Municipal Budget Officer, San Pablo, Zamboanga del Sur;

Section 2. The total amount of **TWENTY-FIVE THOUSAND PESOS (P25,000.00)** shall be transferred to wit:
