## APPROPRIATION ORDINANCE NO. 38-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) FROM THE APPROPRIATION FOR TRAVELLING EXPENSES; OTHER SUPPLIES; TELEPHONE EXPENSES - MOBILE; PRINTING & BINDING EXPENSES; REPAIR & MAINTENANCE - IT EQUIPMENT AND OTHER MOOE UNDER THE OFFICE OF THE MUNICIPAL PLUMBING TO OTHER SUPPLIES AND TELEPHONE EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for TRAVELLING EXPENSES; OTHER SUPPLIES; TELEPHONE EXPENSES - MOBILE; PRINTING & BINDING EXPENSES; REPAIR & MAINTENANCE - IT EQUIPMENT AND OTHER MOOE under the office of the Municipal Budget Officer, San Pablo, Zamboanga del Sur;

Section 2. The total amount of FIFTY THOUSAND PESOS (P50,000.00)) shall be transferred to wit:

Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
