APPROPRIATION ORDINANCE NO. 39-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWENTY-ONE THOUSAND FIVE HUNDRED PESOS (P21,500.00) FROM THE APPROPRIATION FOR REPAIR & MAINTENANCE – SAKYANAN NI NANAY AND OTHER MOOE UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO HIV & AIDS/STI PROGRAM AND TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **REPAIR & MAINTENANCE – SAKYANAN NI NANAY AND OTHER MOOE** under the office of the Municipal Health Officer, San Pablo, Zamboanga del Sur;



Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.


