APPROPRIATION ORDINANCE NO. 41-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF THIRTY NINE THOUSAND SEVENTY SIX PESOS (P39,076.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES, PRINTING & BINDING, OTHER MAINTENANCE & OPERATING EXPENSES, REPAIR AND MAINTENANCE-OFFICE EQUIPMENT, REPAIR AND MAINTENANCE – IT EQUIPMENT & SOFTWARE UNDER THE OFFICE OF THE SECRETARY TO THE SANGGUNIANG TO TRAVELLING EXPENSES AND OTHER SUPPLIES EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **OFFICE SUPPLIES, PRINTING & BINDING, OTHER MAINTENANCE & OPERATING EXPENSES, REPAIR AND MAINTENANCE- OFFICE EQUIPMENT, REPAIR AND MAINTENANCE – IT EQUIPMENT & SOFTWARE** under the office of the Secretary to the Sanggunian, San Pablo, Zamboanga del Sur;

Section 2. The total amount of **THIRTY NINE THOUSAND SEVENTY SIX PESOS (P39,076.00)** shall be transferred to **Travelling Expenses** of the same Office to wit:
