EXCERPT FROM THE MINUTES OF THE 87TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON NOVEMBER 13, 2024.

APPROPRIATION ORDINANCE NO. 42-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF THREN THOUSAND PESOS (P13,000.00) FROM THE APPROPRIATION FOR REPAIR AND MAINTENANCE – IT EQUIPMENT AND OTHER MOOE UNDER THE OFFICE OF THE MUNICIPAL AGRICULTURIST TO TELEPHONE EXPENSES (MOBILE) AND OTHER SUPPLIES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **REPAIR AND MAINTENANCE – IT EQUIPMENT AND OTHER MOOE** under the office of the Municipal Agriculturist, San Pablo, Zamboanga del Sur;

Section 2. The total amount of **THIRTEEN THOUSAND PESOS (P13,000.00)** shall be transferred/augmented to the appropriation for **TELEPHONE EXPENSES (MOBILE) amounting Three Thousand Pesos (P3,000.00) and OTHER SUPPLIES** expenses amounting **Three Thousand Pesos (P3,000.00)** of the same office.

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED and APPROVED, this 13TH day of November, 2024, during the 87TH Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
