RESOLUTION NO. 2024-132

"A RESOLUTION CONFIRMING RESOLUTION NO. 250365 DATED 30 MARCH 2005 AND HEREBY AUTHORIZING MUNICIPAL MAYOR DANILO A. TAUCAN TO EXECUTE A DEED OF DONATION INVOLVING A PORTION OF LAND (CSD-13113-D), SITUATED AT RIBE SCOUT SITE AND BEACH RESORT, TENIAPAN, SAN PABLO, ZAMBOANGA DEL SUR, CONTAINING AN AREAOF TEN THOUSAND (10,000.00) SQUARE METERS, IN FAVOR OF THE DEPARTMENT OF EDUCATION, PROVINCE OF ZAMBOANGA DEL SUR WHICH SHALL BE USED AS SCHOOL SITE OF TENIAPAN NATIONAL HIGH SCHOOL."

WHEREAS, the school head of Teniapan National High School, Arlinda Sistoso Ruizal personally appeared before this August Body in order to request for assistance regarding the Deed of Donation on a portion of land which is now used as the school site of the above-mentioned school;

WHEREAS, records would disclose that on 30 March 2005 this August Body had passed Resolution No. 250365 authorizing the Municipal Mayor, Rolando R. Dolauta, to donate in behalf of the Municipal Local Government Unit of San Pablo a portion of this parcel of land (CSD-13113-D), situated at Ribi Scout Site and Beach Resort, Teniapan, San Pablo, Zamboanga del Sur containing with an area of Ten Thousand (10,000.00) square meters, in favor of the Department of Education;

WHEREAS, it was discovered lately that there was no Deed of Donation being executed in relation to the aforementioned resolution, hence, it is fitting and appropriate that the Deed of Donation be executed by the present administration through incumbent Municipal Mayor DANILO A. TAUCAN and the Assistant Schools Division Superintendent and Officer-In-Charge of the office of the Schools Division Superintendent, DR. MA JUDELYN J. RAMOS, CESO VI.

WHEREFORE, on motion of Vice Mayor Flavio P. Cordero, Jr., severally seconded, be it.

RESOLVED, as it is hereby resolved, CONFIRMING RESOLUTION NO. 250365 DATED 30 MARCH 2005 AND HEREBY AUTHORIZING MUNICIPAL MAYOR DANILO A. TAUCAN TO EXECUTE A DEED OF DONATION INVOLVING A PORTION OF LAND (CSD-13113-D),
